### Why?

Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

#### What?

# How?

All financial companies need to share customers' personal information to run their everyday business. Definitions		
Affiliates	Companies related by common ownership or control. They can be financial and nonfinancial companies.  TSP Financial, LLC has no affiliates.	
Nonaffiliates	Companies not related by common ownership or control. They can be financial and nonfinancial companies.  TSP Financial, LLC's nonaffiliates include custodians, third-party investment managers, and broker-dealers.	
Joint Marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you.  TSP Financial, LLC does not jointly market with nonaffiliates.	

## Other important information

**Nonaffiliates:** We will share your information with nonaffiliates as necessary to service your account(s) including, without limitation, the settlement, billing, processing, clearing, and/or transferring of transactions.

State Laws: We will automatically limit sharing of your information in accordance with applicable state law.
